CFE expressed extreme concern that such a weakening of expectations will seriously undermine the integrity and quality of blended and online offerings at Fresno State. The Chancellor's Office's priority for QLT/ QM "best practices" would be effectively ignored by such a policy.

(c) The previously discussed OBE Checklist to add to the Curriculum Development is still in-progress. May be better to wait until the APM 206

language/ expectations are settled instead of to post and introduce additional confusion.

V. Course/Proposal Reviews.

(a) Wei: It would be helpful/beneficial to have explicit deadlines for OBE reviewers' progress. It would help with planning. VaNee noted that it is very difficult to compel member to do their assigned work. Possibility of receiving a negative service memo indicating lack of participation/follow-through. Keith urged that there be more "nudges" possibly including cc: to relevant department chairs.

Again, plenty of current work that needs to get done. Communicate as needed; cannot wait to "next meeting" to address all questions.
